4.1 Budget 2021 Finance and Stewardship

As of the end of October 2020 Saint Matthews had a negative net income (loss) of \$5,617. Year-to-date at the end of Oct. the loss was \$38,843. Savings had been reduced to \$60K. the outstanding balance on the mortgage is \$219,218.78

We cannot sustain this level of loss. Through the balance of the year we are going to focus on Stewardship and our tithing goals for 2021. Bob will prepare a speech to be delivered to the community on Sunday after mass.
